In-Person vs. Virtual Sessions

In-Person Sessions

There are only 350 in-person slots for on-site participants at the Santa Clara County Office of Education (SCCOE). In-person participants will have access to all keynote sessions and may select one session per time period to attend. In-person participants will also have access to all virtual sessions recordings after the conference.

Virtual Sessions

Since there are only 350 spaces available for in-person participation, the live virtual participation is a great feature of this conference. The conference will have all keynote sessions and selected concurrent sessions will be live streamed on YouTube over the two conference days. Virtual sessions will also be recorded and available to all in-person & virtual participants after the conference.

Measurable Goals & Outcomes

One of the most important goals of Conference presentations is that attendees leave each session with skills or knowledge on a particular topic related to a Conference Track. Presenters are expected to approach their presentation with this in mind. You will be asked to list the expected measurable outcomes or goals for your session.

Presenters are responsible for uploading their own materials/handouts to SCHED.

Promotion of Business Interest

Sale of products is prohibited in conference sessions. If you will be sharing examples of proprietary work as part of your presentation, please supplement the examples with additional projects that you (or your organization) did not have a role in producing. Doing so alleviates the perception of self-promotion and participants also enjoy learning about projects you represent.
